MOST RESPECTFULLY SHEWETH:

1. That the Petitioner had filed the present Civil Appeal before this Hon'ble court challenging the final judgment and order dated 12.08.2015 passed by the Hon'ble Securities Appellate Tribunal, Mumbai.
2. That the applicant herein is the owner of land measuring 235 bighas 07 biswas of land forming part of khasras Nos. 114/396, 114/397, 114/399, 114/404, 114/408, 114/413, 114/414 and 114/415, which is situated at village Manchitiya in Patwar Circle Badi Seedh of Tehsil Phalodi, District Jodhpur (the aforesaid will hereinafter referred to in the present representation as the "**property**").
3. That the aforesaid property was purchased by applicant from one Smt. Maina vide registered sale deed dated 25.05.2012. It is stated that applicant thereafter applied for mutation of the property which was refused by the revenue authorities on the
