- 1. That the above named Civil Appeal No. 13301 of 2015 pending before this Hon'ble Court wherein the matter is likely to be listed before this Hon'ble Court.

2. That the intervenors-respondents are making this application seeking indulgence of this Hon'ble Court for permitting them to intervene in the above said matter because the applicants as intervenors –respondents dues salary are pending, gratuity pending on the petitioner's company of the intervenors-respondents.
3. That the above said civil appeal no. 13301 of 2015 is pending before this Hon'ble Court claiming to protect the intervenors-respondents by this Hon'ble Court. 6. That the Civil Appeal No. 13301 of 2015 is pending before the Hon'ble Supreme Court wherein the Hon'ble Court has ordered a specific direction on 2.2.2016 in para No.12 as under:-
- "The Committee shall also decide as to whether the staff of the company should be continued or relived."
7. That this Hon'ble Court give a direction to the respondents authority to pay all pending outstanding salary, gratuity employee provident fund without any delay to the respondents if the applicants issues/salaries must be settled/down by the respondents in the interest of justice for administration of justice.
8. That the balance of convenience is in favour of the applicants who were employees/staffs of the respondent's

company and had been worked for more than 2 decades without any prejudice. The applicants were removed from the service without giving any information and notice by the respondents. The applicants salary are still pending. gratuity relief, compensation amount and employee provident fund till October, 2015 would not been paid by the respondents.

PRAYER

In view of the aforesaid facts and circumstances of the case, it is, therefore, most respectfully prayed that this Hon'ble Court may graciously be pleased to:-

- [a] allow this application to the applicants and tag up this I.A. with Civil Appeal No. 13301/2015 in the interest of justice for the applicants; and
- [b] pass such other further order or orders as may be deem fit and proper under the circumstances of the case.
