Record of Proceedings

1. The captioned objection was taken up on 08.04.2025, for further proceedings in the matter.
2. The instant objection has been filed by E. Jayakumar, objecting the attachment of properties under Survey Numbers 1) 163/4 – 1 Acre 40 cents, 2) 210/5 – 1 Acres 21 Cents & 3) 211/10 – 1 Acre 75 cents 4) 212/5 – 3 Acres 12 cents 5) 214/1 – 4 Acres 40 cents & 6) 24/1 – 3 Acres 37 cents, situated at Irumpur village, Kalayarkoil Taluk, Sivagangai District, Tamilnadu, covered in MR No 14628/16 and 34101/16, which stands attached by the Committee.
3. Upon perusing the objection and the documents attached thereto, certain documents were found deficient and therefore, vide deficiency letter dated 17/01/2025, mentioning therein the said deficiencies, was issued to the Objector via email dated 20/01/2025. at the email ID viz srbuilderkodai@gmail.com and also via Speed Post AD at the correspondence address of the Objector viz. Perumal Malai Main Road, Palani Road, Perumal Malai, Kodaikanal Taluk, Dindigul District, Tamilnadu, advising him to make good the deficiencies within a period of 30 days from receipt of the said letter. It is noted that the deficiency letter sent via Speed Post AD was duly delivered to the Objector. However, even after lapse of the timeline, no response was received from the Objector. In view of the same, vide email dated 20/01/2025 a final opportunity was granted to the Objector to make good the deficiencies enlisted in the deficiency letter dated 27/02/2025 within a period of 7 days from the receipt of the communication, which was sent through speed post on aforesaid address.
