Whereas **Recovery Certificate No. 9028 of 2026** dated **February 11, 2026** was drawn against **SHASHI JAIN (PAN: ACBPJ2127L) ["Defaulter"]** for sum of **Rs.5,71,000.00/- (Rupees Five Lakh Seventy-One Thousands Only)** along with further interest, all costs, charges and expenses incurred in respect of all the proceedings taken for recovery of the said sum, for non-payment of penalty imposed by **Order/AS/VC/2024-25/31179** dated **January 31, 2025** in the matter of **ISO at BSE-SHASHI JAIN**.

4. In view of the above, you are hereby **directed to release bank accounts/lockers, demat accounts and Mutual Fund Folio etc. of SHASHI JAIN (PAN: ACBPJ2127L) ["Defaulter"]** attached, if any, pursuant to the above notices of attachment with **immediate effect**.
5. This is without prejudice to any other order of attachment or freeze by the competent authority under any law.
