1. Whereas **Recovery Certificate No. 7223 of 2023** dated **October 10, 2023** was drawn against **Sikhar Infrastructure Private Limited PAN: AAHCS7579Q ["Defaulter"]** for sum of **Rs. 5,21,000/- (Rupees Five Lakh Twenty-One Thousand Only)** along with further interest, all costs, charges and expenses incurred in respect of all the proceedings taken for recovery of the said sum, for non-payment of penalty imposed by the AO vide Order no. **Order/VV/PSS/2023-24/28472 dated July 31, 2023** in the matter of **Trading in Illiquid Stock Options at BSE**.
2. And whereas, Notices of Attachment vide AP nos. 15095 & 15096 of 2025 dated December 18, 2025 were issued attaching bank/post office accounts/lockers, demat accounts and mutual fund folios of the Defaulter;
3. And whereas SEBI has recovered the amount of **6,06,000/- (Rupees Six Lakh Six Thousand Only)**, from the defaulter, as was due in April 2026.
4. In view of the above, you are hereby **directed to release bank accounts/lockers, demat accounts and Mutual Fund Folio etc. of Sikhar Infrastructure Private Limited (PAN: AAHCS7579Q) ["Defaulter"]** attached, if any, pursuant to the above notices of attachment with **immediate effect**.
5. This is without prejudice to any other order of attachment or freeze by the competent authority under any law.
