1. Whereas Recovery Certificate No. **RC 4216 of 2021 dated October 21, 2021** has been drawn up by the Recovery Officer against **Mr. Dheerendra Krishan Pratap (PAN: AXMPB0165C) ["Defaulter"]** for recovery of a sum **Rs. 2,23,948/- (Rupees Two Lakh Twenty-Three Thousands Nine Hundred Forty-Eight Only)** along with further interest, all costs, charges and expenses etc. for non-payment of penalty imposed by SEBI Adjudicating Order Authority vide Order No. Order/BD/MG/2020-21/9551 dated 06/11/2020 in the matter of Sai Prakash Properties Development Limited.
2. And whereas Notices of Attachment in the above proceedings were issued attaching the Bank Accounts/ lockers of the Defaulter;
3. And whereas a Special Committee appointed by Hon'ble Supreme Court of India has directed SEBI to release all bank accounts of the aforementioned defaulter w.r.t. Recovery Certificate No. 4216 of 2021 in the matter of M/s Sai Prakash Properties Development Limited.
4. In view of the above, you are hereby directed to release the bank accounts/ lockers of Mr. Dheerendra Krishan Pratap (PAN: AXMPB0165C) attached, if any, pursuant to the above said notices of attachment.
5. **If the defaulter is not having any type of accounts with you, the same need not be informed to SEBI.**
6. **This is without prejudice to any other order of attachment or freeze by the competent authority under any law.**
