- 1) Whereas Recovery Certificate No. 8394 of 2024 dated November 28, 2024 was drawn against **Carona Infra Projects Private Limited (now known as Alright Merchantile Private Limited) (PAN: AADCC4915E)** ["Defaulter"] for sum of **Rs.5,91,000/- (Rupees Five Lakh Ninety one Thousands Only)** along with further interest, all costs, charges and expenses incurred in respect of all the proceedings taken for recovery of the said sum, for non-payment of penalty imposed by Adjudicating Officer vide Order No. Order/BM/DS/2023-24/27772 dated June 27, 2023 in the matter of ISO at BSE.
- 2) And whereas, Notices of Attachment vide AP nos. 14888 & 14889 dated September 22, 2025 were issued attaching bank/post office accounts/lockers, demat accounts and mutual fund folios of the Defaulter;
- 3) And whereas SEBI has recovered the amount of **Rs. 6,51,000/- (Rupees Six Lakh Fifty-One Thousand Only)** from the defaulter as was due in November 2025.
- 4) In view of the above, you are hereby **directed to release bank accounts/lockers, demat accounts and Mutual Fund Folio etc.** of **Carona Infra Projects Private Limited (now known as Alright Merchantile Private Limited) (PAN: AADCC4915E)** attached, if any, pursuant to the above notices of attachment with immediate effect.
- 5) This is without prejudice to any other order of attachment or freeze by the competent authority under any law.
