Whereas Recovery Certificate No. 8969 of 2025 dated December 12, 2025 was drawn against Mr. Mahesh Kumar Sharma (PAN: AYYPS1602E) ["Defaulter"] for sum of Rs. 2,51,000/- (Rupees Two Lacs Fifty-One Thousand Only) along with further interest, all costs, charges and expenses incurred in respect of all the proceedings taken for recovery of the said sum, for non-payment of penalty imposed by QJA QJA/AA/AFD-1/AFD-1-SEC/29946/2023-24 dated December 29, 2023 in the matter of CIG Realty Fund Scheme I, II and IV.
2. And whereas, Notices of Attachment vide AP nos. 15137 & 15138 dated January 2, 2026 were issued attaching bank/post office accounts/lockers, demat accounts and mutual fund folios of the Defaulter;
3. And whereas SEBI has recovered the amount of Rs. 2,53,000/- (Rupees Two Lacs Fifty-Three Thousand Only), online, from the defaulter, as was due in January 2026.
4. In view of the above, you are hereby directed to release bank accounts/lockers, demat accounts and Mutual Fund Folio etc. of Mr. Mahesh Kumar Sharma (PAN: AYYPS1602E) ["Defaulter"] attached, if any, pursuant to the above notices of attachment with immediate effect.
5. This is without prejudice to any other order of attachment or freeze by the competent authority under any law.
