Whereas Recovery Certificate No. **RC 3772 of 2021** dated **June 06, 2021** has been drawn up by the Recovery Officer in the above proceedings for recovery of a sum **Rs. 2,38,348/- (Rupees Two Lakh Thirty-Eight Thousand Three Hundred Forty-Eight Only)** along with further interest, all costs, charges and expenses etc. against **Rainbow Housing Development & Finance Co. Ltd (PAN: AABCR4038D) ["Defaulter"]** and the same was due in respect of the said certificate.

3. And whereas SEBI has recovered the amount of **Rs. 3,51,994/- (Rupees Three Lakh Fifty-One Thousand Nine Hundred Ninety-Four only)**, which includes interest and costs towards full and final settlement of demand raised in the aforesaid recovery certificate.
4. In view of the above, you are hereby directed to release the bank accounts/ lockers/ demat accounts/ mutual fund folios **Rainbow Housing Development & Finance Co. Ltd (PAN: AABCR4038D)** attached, if any, pursuant to the above said notices of attachment under intimation to SEBI.
5. **If the defaulter is not having any type of account/folios with you, the same need not be informed to SEBI.**
6. **This is without prejudice to any other order of attachment or freeze by the competent authority under any law.**
