ORDER RELEASING BANK, DEMAT & MUTUAL FUND ACCOUNTS

Whereas Recovery Certificate No. **RC9082 of 2026 dated April 8, 2026**, has been drawn up by the Recovery Officer in the above proceedings for recovery of a sum of **Rs. 5,31,000/- (Rupees Five Lakh Thirty-One Thousand Only)**, along with further interest, all costs, charges and expenses etc., against **Tavarya Trade-Link Private Limited (PAN: AACCT5851H) ["Defaulter"]** in the matter of Illiquid Stock Options and the same was due in respect of the said certificate.

3. And whereas, SEBI has recovered the entire amount due, which includes interest and costs from the Defaulter against full and final settlement of demand raised in the aforesaid recovery certificate.
4. In view of the above, you are hereby directed to release the Bank Accounts/Lockers, Demat Accounts, Mutual Fund Folios of the Defaulter attached, if any, pursuant to the above said notice/s of attachment.
5. If the defaulter is not having any type of account/folios with you, the same need not to be informed to SEBI.
6. This is without prejudice to any other order of attachment or freeze by the competent authority under any law.
