1. Whereas Recovery Certificate No. **RC 8234 of 2024 dated October 23, 2024** has been drawn up by the Recovery Officer against **Rocket Tips – Prop. Mehul Pravinbhai Jiyani (PAN: AGPPJ1611H) [“Defaulter”]** for recovery of a sum **Rs. 7,39,000/- (Rupees Seven Lakh Thirty-Nine Thousand Only)** along with further interest, all costs, charges and expenses etc. for non-payment of penalty imposed by SEBI order QJA-AA/ROWRO/22665/2022-23 dated December 30, 2022 in the matter of Unregistered Investment Advisory Services.
2. And whereas Notices of Attachment in the above proceedings were issued attaching the Bank Accounts/ lockers, Demat Accounts & Mutual Fund Folios of the Defaulter;
3. And whereas SEBI has recovered the amount towards full and final settlement of demand raised in the aforesaid recovery certificate.
4. In view of the above, you are hereby directed to release the bank accounts/ lockers/ demat accounts/ mutual fund folios of Rocket Tips – Prop. Mehul Pravinbhai Jiyani (PAN: AGPPJ1611H) attached, if any, pursuant to the above said notices of attachment.
5. **If the defaulter is not having any type of account/folios with you, the same need not be informed to SEBI.**
6. **This is without prejudice to any other order of attachment or freeze by the competent authority under any law.**
