**Completion of Recovery Certificate No 4355 of 2021 issued against Venmax Drugs and Pharmaceuticals Limited (PAN: AAACY1073C) in the matter of Venmax Drugs and Pharmaceuticals Limited**

Recovery Certificate No. 4355 of 2021 dated December 08,2021 was drawn against Venmax Drugs and Pharmaceuticals Limited (PAN: AAACY1073C) for a sum of Rs.31,45,986/- (Rupees Thirty One Lakhs Forty Five Thousands Nine Hundred Eighty Six Only) along with further interest, all costs, charges and expenses incurred in respect of all the proceedings taken for recovery of the said sum, for non-payment of Penalty imposed by the WTM vide order no. WTM/AB/IVD/ID19/12587/2021-22 dated 14/07/2021 in the matter of Venmax Drugs and Pharmaceuticals Limited.

Whereas Recovery Certificate No. 4355 of 2021 has been modified by the Recovery Officer on Dec 20, 2022 for recovery of a sum of Rs.11,81,000/- (Rupees Eleven Lakhs Eighty-One Thousand Only) against Venmax Drugs and Pharmaceuticals Limited (PAN: AAACY1073C) along with interest and costs in respect of the said certificate in the above Recovery Proceedings pursuant to the Hon'ble SAT Order dated Nov 14,2022 in appeal no. 759 of 2021,the penalty amount has been reduced to Rs. 10 Lakhs.

In view of the payment of the amount **Rs.15,71,411/- (Rupees Fifteen Lakhs Seventy One Thousand Four Hundred and Eleven Only)** due under the Recovery Certificate, the said Recovery Certificate No. 4355 of 2021 is hereby completed in exercise of powers under sub-section (1) of Section 28A of the Securities and Exchange Board of India Act, 1992 read with Section 224 of the Income-Tax Act, 1961.
