Whereas a **Certificate No. RC9052 of 2026 dated February 26, 2026**, has been drawn up by the Recovery Officer against **Anita Devi Chokhani (PAN: ACWPC0520B)** ["Defaulter"] and the sum of **Rs. 5,21,000/- (Rupees Five Lakh Twenty-One Thousand Only)** along with further interest, all costs, charges and expenses was due from them in respect of the said certificate in the above Recovery Proceedings for recovery of the said sum, for non-payment of penalty imposed by the Adjudicating Officer vide Order No. Order/JS/VC/2025-26/31809 dated November 27, 2025 against Anita Devi Chokhani (PAN: ACWPC0520B) in the matter of Illiquid Stock Options.
2. And whereas Notices of Attachment in the above proceedings dated March 17, 2026 were issued attaching the Bank and Demat accounts. Mutual fund folios of the Defaulter.
3. And whereas, SEBI has recovered an entire amount, which includes interest and costs from the Defaulter against full and final settlement of demand raised in the aforesaid recovery certificate.
4. In view of the above, you are hereby directed to release the Bank Accounts/Lockers, Demat Accounts, Mutual Fund folios of the Defaulter attached, if any, pursuant to the above said notice/s of attachment.
5. If the defaulter is not having any type of account/folios with you, the same need not be informed to SEBI.
6. This is without prejudice to any other order of attachment or freeze by the component authority under any law.
