- 1) Whereas Recovery Certificate No. 9251 of 2026 dated July 27, 2026 has been drawn up by the Recovery Officer in the above proceedings for recovery of a sum of Rs.5,76,000.0/- (*Rupees Five Lakh Seventy-Six Thousands Only*) along with further interest, costs, charges and expenses etc. against Neha Aggarwal [Defaulter] (PAN: AQDPA1749D) in the matter of trading based stock recommendations using social media YouTube in the scrip of Sadhna Broadcast Ltd. and the same was due in respect of the said certificate.

- 4) In view of the above, you are hereby directed to **release bank accounts/lockers, demat accounts and Mutual Fund Folio etc. of Neha Aggarwal (PAN: AQDPA1749D) attached**, if any, pursuant to the above notices of attachment with immediate effect.
- 5) If the defaulter is not having any type of account/folios with you, the same need not be informed to SEBI.
