Important Information regarding Paper 2 of Phase II

User Manual, FAQs, Information Handout and Mock exam

As informed earlier to candidates of Information Technology Stream that Paper 2 of Phase II examination (Coding test) shall be conducted on September 14, 2024.

In this regard, candidates may note that the online Coding test shall be conducted by Centre for Development of Advanced Computing (C-DAC), on behalf of SEBI.

Please note the following with respect to the coding test:

A. USER MANUAL, DEATILED FAQs and INFORMATION HANDOUT

In order to enable candidates, who have qualified for Paper 2 of Phase II of Information Technology Stream, to get accustomed with "Parikshak", an automated platform which shall be used to evaluate programming skills i.e. the coding test scheduled to be held on September 14, 2024, a user manual, detailed FAQs for "Parikshak" and information handout have been uploaded on the SEBI website.

B. MOCK EXAM ON SEPTEMBER 04, 2024

A mock exam is also being conducted on September 04, 2024 in order to make candidates familiar with the Parikshak platform before the actual coding test. A separate email communication in this regard shall also be shared with the candidates. However, brief details of the mock exam are given below:

- System URL for mock exam: <https://parikshak.in>

- Duration: 1 Hour & 30 minutes (**Candidates are required to login between 10:00 AM – 10:15 AM in order to access mock exam**)
- Mock exam start time: 10:30 AM
Note: In case candidates' login after 10:15 AM, they shall not be able to access the mock exam. All candidates are advised to note the same.
- Mock exam end time: 12:00 PM
- Number of Problems: 3
- Location: Anywhere (Candidates can login from their pc/laptop for the examination)

At the home screen of “Parikshak”, candidates would be required to enter Username and Password. **The Username and Password for login shall be shared with eligible candidates on their registered email id and mobile numbers.** Candidates who have qualified for Phase II examination only would be eligible.

C. SAMPLE ASSIGNMENT FOR PRATICE:

A sample assignment namely “**SEBI Practice**” (available under “**Assignment**” tab in **Parikshak**) has also been created for candidates to practice which will get enabled from August 14, 2024 onwards. The same username and password can be used for practice in the Parikshak environment. The “Parikshak” can be accessed from <https://parikshak.in>. The sample assignment shall be available for practice till September 13, 2024. The candidates would be required to choose one of the languages from C++/JAVA/Python before the candidates can start solving the problem.

Candidates are advised to go through the User Manual, detailed FAQs and Information handout carefully before attempting the mock exam as well as practice.
