**Recruitment of Officers in Grade A (General, Legal, Engineering,
Research And Official Language Streams) –**

**Clarification w.r.t results of Phase II published on SEBI website on March
18, 2021**

SEBI is in receipt of various queries from candidates claiming that there are certain roll numbers appearing in Phase II results which were not appearing in Phase I results for General Stream.

In this regard, it is clarified that there were certain candidates who had applied for two streams and had qualified in the Phase I examination in both the streams. However, since the Phase II exam was held in a single session, only one roll number (i.e the roll number corresponding to the latest registration number of the candidate) was used for administrative purpose, as already mentioned in the call letter for Phase II. The same roll number has been used for merit listing which was used during the Phase II exam and accordingly results for Phase II examination has been published on the SEBI website.

A list of such candidates who had qualified for Phase II in two streams along with their roll nos. in Phase I (different roll no. for each stream), the roll no. retained for Phase II examination and the stream(s) in which the candidate has qualified in Phase II is attached.
