Based on the review of PA, DPS and LoF, the IDC is of the opinion that the Offer Price of ₹12 (Rupees Twelve only) per Equity Shares offered by the Acquirer (more than the highest price amongst the selective criteria mentioned under Justification of Offer Price) is in line with the regulation prescribed by SEBI under the SEBI (SAST) Regulations and prima facie appears to be justified
