1. RISK FACTORS

- i. In the event that either (a) the regulatory approvals are not received in a timely manner, (b) there is any litigation to stay the offer, or (c) SEBI instructs the Acquirer not to proceed with the offer, then the offer proceeds may be delayed beyond the schedule of activities indicated in this Letter of Offer. Consequently, the payment of consideration to the public shareholders of FSL, whose shares have been accepted in the offer as well as the return of shares not accepted by the acquirers may be delayed.
- ii. The acquirers intends to make an offer for 20% of the voting capital amounting to 10, 09, 560 equity shares of FSL under the SEBI (SAST) regulations, 1997. (Hereinafter referred to as “**The Acquirer**” or “**Acquire**”), has acquired on spot delivery contract basis as per the Securities and Contracts Regulation (Act), 1956 on **Friday, August 05, 2005, 16,14,500** (Sixteen Lac Fourteen Thousand Five Hundred Only) fully paid up equity shares of Rs.10/- each representing 31.98 % of the total paid up and voting rights of M/s **FACTS SECURITIES LIMITED**, having its registered office at **301, Camy House, Cawasji Hormusji Street, Marine Lines, MUMBAI – 400 002** (hereinafter referred to as “**FSL/the Target Company**”)” from the promoters of FSL, **Balveer Singh Choudhary, Deepak Singhvi** all are resident Indian, **Netlon Trading P Ltd** a company incorporated under The Companies Act, 1956 and having its registered office at 301, Camy House, Cawasji Hormusji Street, Marine Lines, MUMBAI – 400 002, **Shakti Shareshoppe Pvt Ltd.** a company incorporated under The Companies Act, 1956 and having its registered office at 301,

Camy House, Cawasji Hormusji Street, Marine Lines, MUMBAI – 400 002 and **Whiteline Securities P Ltd** a company incorporated under The Companies Act, 1956 and having its registered office at 1/3 Satya Jeeven Soceity, LBS Marg, Kurla (W) , MUMBAI – 400 070 (*hereinafter referred to as “Sellers”*), at a price of Rs. 3.00 (Rupees Three only) per fully paid up equity share payable in cash (“**Negotiated Price**”). The total consideration for the shares acquired as mentioned above is Rs. 48,43,500/- (Rupees Forty Eight Lacs Forty Three Thousand Five Hundred Only)

- 3.1.2 Due to the acquisition as mentioned para 3.1.1, and upon completion of this open offer in terms of the Securities and Exchange Board of India (Substantial Acquisition of Shares and Takeovers) Regulations, 1997, the change of control of Target Company shall be effected and acquirer will not exercise his voting right till the completion of the offer.
- 3.1.3 Pursuant to the acquisition of Shares by Acquirer and in compliance with Regulation 10 & Regulation 12 of the Takeover Regulations, Acquirer is hereby making an Offer to the public shareholders of FSL to acquire 10,09,560 equity shares of Rs. 10/- each representing 20.00 % of the total paid up capital/ voting share capital of “FSL”, at a price of Rs. 4.00 (Rupees Four only) per equity share (hereinafter referred to as “**the Offer Price**”) fully paid equity shares payable in cash (hereinafter referred as “**the Offer**”).
- 3.1.4 As on the date of Public Announcement, the Acquirer hold 17,64,500 (Seventeen Lacs Sixty Four Thousand Five Hundred only) fully paid up equity shares of Rs.10/- each representing 34.96% of the total paid up equity share capital / voting Share Capital of the Target Company
- 3.1.5 The acquirer as mentioned under para 3.1.1 above acquire 16,14,500 fully paid up equity shares/ voting share capital of the target company at the price of Rs. 3.00 (Rupees Three Only).
- 3.1.6 Neither the Acquirer, sellers nor the Target Company have been prohibited by SEBI from dealing in securities, in terms of direction under Section 11B of the SEBI Act or under any of the Regulations made under the SEBI Act.
- 3.1.7 Acquirer have not acquired any shares of the Target Company after the date of Public Announcement till the date of Letter of Offer.
- 3.1.8 There may be a change in the composition of the Board of Directors of the Target Company as per SEBI (SAST) Regulation 1997 and will be done on the completion of offer.

3.2 The Offer

- 3.2.1 The Acquirer have made a Public Announcement in all the editions of the following newspapers, namely, i) **Financial Express (English)** and ii) ‘**Jansatta**’ (Hindi) and ‘**Nav Shakti**’ (Marathi), which appeared in the newspapers on Friday, August 11, 2005 in terms of Regulation 15 and pursuant to Regulation 10 and 12 of the SEBI (SAST) Regulations, 1997. **The Public Announcement is also available on the SEBI website at www.sebi.gov.in.**
- 3.2.2 The Acquirer make this Open Offer under the SEBI (SAST) Regulations, 1997, to acquire, by tender, 10,09,560 equity shares of Rs. 10/- each representing 20.00 % of the total paid up capital/ voting share capital of Rs. 10/- each from the shareholders of FSL, other than the acquirer himself, on the terms and subject to the conditions set out in this Letter of Offer, at a price of Rs. 4.00 (Rupees Four Only) per equity shares of Rs. 10/- each fully paid up equity share payable in cash. These equity shares are to be acquired by the Acquirer, free from all liens, charges and encumbrances and together with all rights attached thereto, including the right to all dividends, bonus and rights offer declared hereafter.
- 3.2.3 **The Offer is not subject to any minimum level of acceptances from the shareholders i.e. it is not a conditional offer.**
- 3.2.4 The Acquirer has not acquired any equity shares in the Target Company since the date of Public Announcement i.e. **August 11, 2005**, upto the date of Letter of Offer.

3.3 Object of the Offer

- 3.3.1 The Offer to the Public shareholders of FSL is for the purpose of acquiring 20.00 % of the total paid up capital. After the proposed Offer and transfer of the shares so acquired, the Acquirer will achieve substantial acquisition of shares and voting rights, accompanied with effective management control over the Target Company.

- 3.3.2** The object and the purpose of the Acquirer are to expand the business operations of FSL. The acquirer proposes to diversify in the real estate development and construction business. However, depending on the requirements and expediency of the business situation and subject to the provisions of the Companies Act, 1956, Articles of Association of FSL and all applicable laws, rules and regulations, the Board of Directors of FSL will take appropriate business decisions from time to time in order to improve the performance of the Target Company. The Acquirer may make changes in the management and Board of Directors of the Target Company. The Acquirer may also change the name of the Target Company after completion of the Offer.

- 4.1.4** The Acquirer have purchased **16,14,500** (Sixteen Lac Fourteen Thousand Five Hundred Only) fully paid up equity shares of Rs.10/- each representing 31.98 % of the total paid up equity share capital / voting Share capital of the Target Company during the 12 month period prior to the date of Public Announcement at the price of Rs. 3.00 (Rupees Three Only) which was acquired as mentioned under Para 3.1.1 above.
