3. DETAILS OF THE OFFER

3.1 Background of the Offer

3.1.1 This Offer is being made to acquire substantial shares and control over the Target Company in terms of the provisions of Regulations 3(1) & 4 of SEBI (SAST) Regulations, 2011.

3.1.2 The Acquirer has entered into the SPA with the Selling Shareholders, on November 19, 2022, for the acquisition of 97,14,300 (Ninety-Seven Lakhs Fourteen Thousand Three Hundred) Equity Shares representing 54.57% of the paid up and Voting Equity Share Capital of Target Company at a price of Rs. 0.10/- (Ten Paise Only) per Equity Share aggregating to Rs. 9,71,430/- (Rupees Nine Lakhs Seventy One Thousand Four Hundred and Thirty) payable in cash along with the acquisition of control over the Target Company.

3.1.3 The details of the Promoter Sellers, who entered into the SPA, on November 19, 2022, with the Acquirer is stated hereunder:

3.1.4 The prime objective of the Acquirer for this Open Offer is the substantial acquisition of Equity Shares and voting rights and control over the management and affairs of the Target Company.

3.1.5 The Offer is not as a result of global acquisition resulting in the indirect acquisition of the Target Company.

3.1.6 The salient features of the Share Purchase Agreements are as follows:

- I. The Promoter Sellers are holding 97,14,300 Equity Shares, constituting 54.57% of the voting share capital of the Target Company.
- II. The Promoter Sellers have agreed to sell 97,14,300 Equity Shares and the Acquirer has agreed to acquire 97,14,300 Equity Shares, constituting 54.57% of the Equity Share Capital/Voting Share Capital of the Target Company, at a negotiated price of at a negotiated price of Rs. 0.10/- (Rupees Ten Paise Only) per sale share, aggregating to an amount of Rs. 9,71,430/- (Rupees Nine Lakhs Seventy One Thousand Four Hundred and Thirty) payable in accordance with terms and conditions stipulated of the Share Purchase Agreement.
- III. The shares sold are free from all charges, encumbrances, pledges, lien, attachments, and litigations are not subjects' lock-in period.
- IV. The aggregate entire purchase consideration for the shares sold aggregating to an amount of Rs. 9,71,430/- (Rupees Nine Lakhs Seventy One Thousand Four Hundred and Thirty) shall be payable by the Acquirer to the Promoter Sellers at the time of signing of the Share Purchase Agreement.
- V. After completion of this Offer and consummation of the Share Purchase Agreement, the Sellers shall not hold any Equity Shares and Voting Share Capital in the Target Company, and hence shall be no longer be the Shareholders of the Target Company in any capacity.
- VI. The Promoter Sellers shall sell, convey, and deliver to the Acquirer the shares sold, and the Acquirer shall purchase, acquire, and accept the said Sale Shares from the Promoter Sellers.
- VII. The Acquirer has no intention to delist the Target Company pursuant to this Offer.
- VIII. The Acquirer doesn't hold any Equity Shares of the Target Company.

IX. The Acquirer and the sellers have agreed to abide by their obligations as contained in the SEBI (SAST) Regulations.

X. Non-compliance with any provisions of the SEBI (SAST) Regulations will lead to the termination of the Share Purchase Agreements, effecting such sale from being acted upon by the sellers or the Acquirer.

3.1.7 The recommendations of the committee of Independent Directors as constituted by the Board of Directors of the Target Company for the Offer will be published at least two working days before the commencement of the Tendering Period, in the same newspapers where the Detailed Public Statement was published and a copy whereof shall be sent to SEBI, BSE and Manager to the Offer and in case of a competing Offer/s to the manager/s to the Open Offer for every competing Offers.

3.2 Details of the Proposed Offer

3.2.1 In accordance with Regulations 13(1) and 15(1) of SEBI (SAST) Regulations, 2011, the PA was issued on November 19, 2022 by the Manager to the Offer, for and on behalf of the Acquirer. A copy of the said Public Announcement was filed with BSE, SEBI and sent to the Target Company at its registered office on November 19, 2022.

3.2.3 The Acquirer have made this Open Offer in terms of SEBI (SAST) Regulations, 2011 to the Public Shareholders of Target Company to acquire up to 46,28,390 (Forty-Six Lakh Twenty-Eight Thousand Three Hundred and Ninety) fully paid up Equity Shares of Rs. 10.00/- (Rupees Ten only) each representing 26.00% of the paid-up share capital in accordance with Regulation 9(1)(a) of the SEBI (SAST) Regulations, 2011.

3.2.4 As on date of this Letter of Offer, the Target Company doesn't have:

- Outstanding instruments in warrants or options or fully or partly convertible debentures/preference shares/ employee stock options etc., which are convertible into Equity Shares at a later stage.
- Equity Shares which are forfeited or kept in abeyance;
- Equity Shares which are subject to any lock-in obligations.

3.2.5 There is no differential pricing in the Offer.

3.2.6 This is not a competitive bid in terms of the provisions of Regulation 20 of the SEBI (SAST) Regulations, 2011.

3.2.7 This Offer is made to all the Public Shareholders of the Target Company except the Acquirer in terms of provision of the regulation 7(6) of SEBI (SAST) Regulations, 2011.

3.2.8 The Offer Price has been arrived in accordance with Regulation 8(2) of the SEBI (SAST) Regulations, 2011. Assuming full acceptance of the Offer, the total consideration payable by the Acquirer in accordance with the SEBI (SAST) Regulations, 2011 will be the Maximum Consideration.

3.2.9 This Offer is not a conditional Offer and is not subject to any minimum level of acceptance from the shareholder. The Acquirer will accept the Equity Shares of Good Value Irrigation Limited tendered in valid form in terms of this Offer up to a maximum of 46,28,390 (Forty-Six Lakhs Twenty-Eight Thousand Three Hundred And Ninety) fully paid up Equity Shares of Rs. 10.00/- (Rupees Ten only) being 26.00% of the paid-up share capital of the Target Company.

3.2.10 The Acquirer shall not acquire any shares of Target Company after the date of PA i.e. November 19, 2022 and up to the date of this LOF.

3.2.11 Public Shareholders who tender their Equity Shares in this Offer shall ensure that the Equity Shares are clear from all lien, charges and encumbrance. The Shares sold will be acquired, subject to such Shares

sold being validly tendered in this Open Offer, together with all the rights attached thereto, including all the rights to dividends, bonuses and right offers declared.

- 3.2.12 This Offer is not a competing offer in terms of Regulation 20 of the SEBI (SAST) Regulations, 2011 and there has been no competing Offer as of the date of this Letter of Offer.
- 3.2.13 The Manager to the Offer does not hold any Equity Shares in the Target Company as of the date of DPS and this LOF. The Manager to the Offer further declares and undertakes that it will not deal on its own account in the Equity Shares of the Target Company during the Offer Period.
- 3.2.14 Upon completion of the Open Offer (assuming full acceptances in the Open Offer) and the proposed transaction, the public shareholding of the Target Company may fall below the minimum level of public shareholding as required to be maintained as per Regulation 38 of the SEBI (LODR) Regulations (as defined below) read with Rule 19A of the SCRR (as defined below). While the Acquirer is required to take necessary steps to facilitate the compliance by the Target Company with the relevant provisions prescribed under the Securities Contracts (Regulation) Rules, 1957 (SCRR) as per the requirements of Regulation 7(4) of the SEBI (SAST) Regulations, 2011 and the SEBI (LODR) Regulations 2015, within the time period stated therein through permitted routes and any other such routes as may be approved by SEBI from time to time, any failure to comply with the conditions of aforesaid regulations could have an adverse effect on the price and tradability of the Equity Shares of the Target Company.

4.1.2 The Acquirer is a Post Graduate in Business Administration and Journalism.

4.1.3 The Acquirer has rich experience of over Fifteen years in the field of Business Development and Media Consultancy. Currently, the Acquirer is the Director of Avni Itinfra Ventures Limited, OGB Security Private Limited and White Mountain Media Private Limited.

The Acquirer is playing a vital role in formulating business strategies and development and effective implementation of the same.

4.1.4 Acquirer holds directorship in the following Companies:

- Avni Itinfra Ventures Limited
- OGB Security Private Limited
- White Mountain Media Private Limited

4.1.5 Acquirer does not hold any Equity Shares of the Target Company and has not acquired any Equity Share of the Target Company during the 12 (Twelve) months period prior to the date of Public Announcement.

4.1.6 The Net worth of the Acquirer as on August 30, 2022, is Rs. 4.09/- Crore (Rupees Four Crore Nine Lacs Only) and the same is certified by Mr. Dhananjay Jha, Chartered Accountant, partner of M/s. A D S G & Co., having its office at E-7-A, Office No. 302, 3rd Floor, Friends Complex, Laxmi Nagar, Delhi – 110092 (Membership No.: 539774) vide his certificate dated 17th November 2022.

4.1.7 The Acquirer hereby confirms that the Acquirer has not been banned or prohibited by SEBI from accessing the stock market or dealing in securities.

5. DECLARATIONS BY ACQUIRER

5.1 The Acquirer has confirmed that he is not categorized as a "Willful Defaulter" in terms of Regulation (1) (ze) of the SEBI (SAST) Regulations, 2011. He further confirmed that he and other companies, in which he is promoter and/or director, is not appearing in the willful defaulter's list of the Reserve Bank of India.

5.2 The Acquirer has not been prohibited by SEBI from dealing in securities, in terms of the provisions of Section 11B of the SEBI Act, 1992, as amended ("SEBI Act") or under any other Regulation made under the SEBI Act.

- 6.3 The Target Company is engaged in the business operations in manufacture, import, export and deal in all kinds of irrigation system, equipment, dosing liquids, liquid manures, plant growth regulators, growth hormones and all things connected herewith or related thereto.
- 6.4 As on the date of DPS, the Authorized Share Capital of the Target Company is Rs. 1,80,00,000/- comprising of 1,80,00,000 Equity Shares of Rs. 10/- each. The paid-up Equity Share Capital of the Target Company is Rs. 17,80,15,000/- comprising 1,78,01,500 Equity Shares of Rs. 10/- each fully paid up.
- 6.5 As on date, except 623,800 Equity Shares of the Target Company, no other shares are partly paid up. There are no outstanding warrants or options or similar instruments, convertible into Equity Shares at a later stage. No shares are subject to any lock-in obligations.
- 6.6 The Target Company has complied with all the provisions of the listing agreement under the SEBI (LODR) Regulations, 2015 from time to time and there are no punitive actions except following instances of non-compliance mentioned hereunder:
- 6.7 On November 21, 2019 vide notice no. 20191121-19, trading in Equity Share of the Target Company was suspended due to non-payment of annual listing fees as per Regulation 14 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015.

However, the Target Company took all the measures in regards to the payment of annual listing fees and thus BSE vide Notice No. 20221103-25 dated November 03, 2022 revoked the suspension w.e.f. November 11, 2022 and trading to be resumed in group XT.

All the Equity Shares of the Target Company are presently listed on the BSE Limited (“BSE”) having the symbol GOVAI, Script code 531997: and the ISIN of Equity Shares of the Target Company is INE164D01010.

7.1.5 There have been no corporate actions in the Target Company warranting adjustment of relevant price parameters under Regulation 8(9) of the SEBI (SAST) Regulations, 2011.

7.1.6 If the Acquirer acquire or agrees to acquire any Equity Shares or voting rights in the Target Company during the Offer Period, whether by subscription or purchase, at a price higher than the Offer Price, the Offer Price shall stand revised to the highest price paid or payable for any such acquisition in terms of Regulation 8(8) of SEBI (SAST) Regulations, 2011.

Provided that no such acquisition shall be made after the 1 (One) working day prior to the commencement of the Tendering Period and until the expiry of the Tendering Period. 7.2.2 The Acquirer has adequate financial resources and has made firm financial arrangements for financing the acquisition of the Equity Shares under the Open Offer, in terms of Regulation 25(1) of the SEBI (SAST) Regulations, 2011. The acquisition will be financed through the internal resources of the Acquirer and no borrowings from any bank and/or financial institution are envisaged.

- 7.2.6 Based on the above and in the light of the escrow arrangements, the Manager to the Offer is satisfied that firm arrangements have been put in place by the Acquirer to fulfill its obligations through verifiable means in relation to the Offer in accordance with the SEBI (SAST) Regulations, 2011.
- 7.2.7 In case of upward revision of the Offer Price and/or the Offer Size, the Acquirer shall deposit additional appropriate amount into an Escrow Account to ensure compliance with Regulation 18(5) of the SEBI (SAST) Regulations, 2011, prior to effecting such revision.

- 8.1.5 This Offer is subject to the receipt of the statutory and other approvals as mentioned in paragraph 8.4 of this LOF. In terms of Regulation 23(1) of the SEBI (SAST) Regulations, 2011, if the statutory approvals are refused, the Offer would stand withdrawn. In the event of a withdrawal of the Offer, the Acquirer (through the Manager to the Offer) shall, within 2 (Two) Working Days of such withdrawal, make a public announcement, in the same newspapers in which the Detailed Public Statement was published, in accordance with Regulation 23(2) of the SEBI (SAST) Regulations, 2011 and such public announcement also will be sent to SEBI, BSE and the Target Company at its registered office.
- 8.1.6 While it would be ensured that the Letter of Offer is dispatched by the due date to all the eligible Public Shareholders as on the Identified Date, non-receipt of this Letter of Offer by any member entitled to this Offer shall not invalidate the Offer in any manner whatsoever.

- 9.4.7 For custodian participant, orders for demat Equity Shares early pay-in is mandatory prior to confirmation of order by the custodian. The custodians shall either confirm or reject orders not later than 6:00 PM on the last day of the Tendering Period. Thereafter, all unconfirmed orders shall be deemed to be rejected.
- 9.4.8 The details of settlement number for early pay-in of Equity Shares shall be informed in the issue opening circular that will be issued by the Stock Exchanges / Clearing Corporation, before the opening of the Offer.
- 9.4.9 The Public Shareholders will have to ensure that they keep their DP account active and unblocked to successfully facilitate the tendering of the Equity Shares and to receive credit in case of return of Equity Shares due to rejection or due to prorated offer.
- 9.4.10 The cumulative quantity tendered shall be made available on the website of the BSE (www.bseindia.com) throughout the trading sessions and will be updated at specific intervals during the Tendering Period.

9.5 Procedure for tendering Equity Shares held in physical form

- 9.5.1 In accordance with the Frequently Asked Questions issued by SEBI, 'FAQs – Tendering of physical shares in buyback offer/Open Offer /exit offer /delisting' dated February 20, 2020 and SEBI circular no. SEBI/HO/CFD/CMD1/CIR/P/2020/144 dated July 31, 2020 issued by SEBI the Public Shareholders holding securities in physical form are allowed to tender Equity Shares in Offer through tender offer route. However, such tendering shall be as per the provisions of respective regulations.

- 9.5.4 After placement of order, as mentioned in paragraph 9.5.3, the Selling Broker / eligible Public Shareholder must ensure delivery of the Form of Acceptance-cum-Acknowledgement, TRS, original share certificate(s), valid share transfer form(s) and other required documents either by registered post or courier or hand delivery to the Registrar to the Offer (at the address mentioned on the cover page not later than 2 (Two) days from the Offer Closing Date (by 5 PM). The envelope should be super scribed as "Limited Open Offer". One copy of the TRS will be retained by the Registrar to the Offer and it will provide acknowledgement of the same to the Selling Broker.
- 9.5.5 Public Shareholders holding physical Equity Shares should note that physical Equity Shares will not be accepted unless the complete set of documents is submitted. Acceptance of the physical Equity Shares by the Acquirer shall be subject to verification as per SEBI (SAST) Regulations, 2011 and any further directions issued in this regard. Registrar to the Offer will verify such orders based on the documents submitted on a daily basis and till such time the BSE shall display such orders as unphysical bids. 9.7.4 In case of non-receipt of the Letter of Offer, such Public Shareholders of the Target Company may download the same from the SEBI website i.e. www.sebi.gov.in or obtain a copy of the same from the Registrar to the Offer on providing suitable documentary evidence of holding of the Equity Shares of the Target Company.

9.8 Settlement Process

9.8.1 On closure of the Offer, reconciliation for acceptances shall be conducted by the Manager to the Offer and the Registrar to the Offer and the final list of accepted Equity Shares tendered in this Offer shall be provided to the designated stock exchanges to facilitate settlement on the basis of Equity Shares transferred to the Clearing Corporation.

9.8.2 The settlement of trades shall be carried out in the manner similar to settlement of trades in the acquisition Window Circulars.
