RISK FACTORS:

Given below are the risks related to the proposed Offer and those associated with the Acquirers:

Relating to the Proposed Offer:

- 1) As of the date of this Letter of Offer, to the best of the knowledge of the Acquirers, there are no other Statutory Approvals required by the Acquirers except the approval from Reserve Bank of India (“**RBI**”). The Target Company being a Non-Banking Finance Company (“**NBFC**”), registered with the Reserve Bank of India (“**RBI**”), any change in stake of a NBFC beyond specified limits requires prior approval of RBI in terms of Master Direction-Non Banking Financial Company-Systematically Important Non-Deposit taking Company and Deposit taking Company (Reserve Bank) Directions, 2016 bearing reference no. DNBR. PD. 007/03.10.119/206-17 (as updated till May 31, 2018) (“**RBI Directions**”). The Target Company had filed the Application with RBI, Kolkata on September 12, 2019. The RBI, pursuant to its letter no. DNBS.RO.Kol.No.734 /08.02.400/2019-20 dated November 25, 2019, has communicated that it has granted its approval/NOC to the Acquirers for the proposed change in management and Control of the Target Company.

In case any other approvals are required by the Acquirers prior to the completion of the Offer, and for the completion of the underlying transaction pursuant to the Share Purchase Agreement, this Offer shall also be subject to such other approvals and the Acquirers and/ or the Target Company (as applicable) shall make the necessary applications for such other Approvals.

- 2) In case of delay in receipt of any statutory approvals mentioned above or which may be required by the Acquirers at a later date, as per Regulation 18(11) of SEBI (SAST) Regulations, 2011. SEBI may, if satisfied, that the delay in receipt of the requisite Statutory Approvals was not attributable to any wilful default, failure or neglect on the part of the Acquirers to diligently pursue such approvals, grant an extension of time for the purpose of completion of this Offer, subject to the Acquirers agreeing to pay interest to the Public Shareholders for such delay at such terms and conditions as may be specified by SEBI.
- 3) Where the statutory approvals extend to some but not all of the Public Shareholders, the Acquirers shall have the option to make payment to such Public Shareholders in respect of whom no statutory approvals are required in order to complete this Offer.
- 4) In case of over-subscription in the Offer, as per the Regulations, acceptance would be determined on a proportionate basis and hence there is no certainty that all the Equity Shares tendered by the shareholders in the Offer will be accepted.
- 5) Shareholders who tender the Equity Shares in acceptance of the Offer shall not be entitled to withdraw their shares, even if the acceptance of equity shares under this Offer and despatch of consideration are delayed.
- 6) No Shares will be accepted in physical mode pursuant to PR No.: 51/2018 dated December 03, 2018 issued by SEBI wherein requests for effecting transfer of securities shall not be processed after March 31, 2019 unless the Securities are held in the dematerialized form with a Depository.

- 1) The Acquirers makes no assurance with respect to the financial performance of the Target Company and their investment/divestment decisions relating to their proposed shareholding in the Target Company.

3. DETAILS OF THE OFFER

3.1. BACKGROUND OF THE OFFER

3.1.1. This Open Offer is being made by Mr. Yatin Sanjay Gupte (“Acquirer 1”), Mr. Sojan V Avirachan (“Acquirer 2”) and Mr. R Venkataramana (“Acquirer 3”) (hereinafter collectively referred to as “Acquirers”) to the Equity Shareholders of Orchid Securities Limited (hereinafter referred to as “OSL”/“Target Company”) pursuant to and in compliance with regulation 3(1) and 4 of the Regulations to acquire upto 10,50,000 Equity Shares of ₹10 each representing 35% of the Equity Share Capital of the Target Company (“Offer Size”) at a price of ₹7.50 (Rupees Seven and Paise Fifty only) per Equity Share (“Offer Price”), payable in cash, subject to the terms and conditions set out in the PA, DPS, DLoF and LoF that will be sent to the Public Shareholders of the Target Company.

3.1.2. The details of the Transactions which triggered the Open Offer are as under:

The Acquirers have entered into a Share Purchase Agreement (“SPA”) with the existing Promoters/Promoter Group (hereinafter referred to “Selling Shareholders”/“Sellers”) of the Target Company for 10,70,600 Equity Shares representing 35.69% of the Equity Share Capital of the Target Company at a price of ₹4 (Rupees Four only) per Equity Share. Post SPA, the Shareholding of the Acquirers will increase beyond 25% of the Equity Share Capital of the Target Company and hence this has triggered the Open Offer. Note: Mrs. Priyanka Gairola alias Mrs. Priyanka Birmecha forming part of Promoter(s)/Promoter(s) Group will continue to hold 86,800 Equity Shares representing 2.89% of the paid-up capital of the Target Company after the completion of Takeover formalities. She shall be re-classified as Public Shareholder subject to compliance of Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 [SEBI (LODR) Regulations, 2015].

The Acquirers have paid an Earnest Money Deposit (“EMD”) of ₹15,26,400 to the Sellers at the time of signing of the Share Purchase Agreement. Thereafter, the Acquirers have paid the entire balance amount of ₹27,56,000 during December 2019-February 2020 period to the sellers and accordingly Shares have been transferred to the Demat account of the respective Acquirers.

3.1.3. The Sellers have not been prohibited by SEBI from dealing in securities, in terms of directions issued under Section 11B of the SEBI Act, 1992, as amended or under any other regulation made under the SEBI Act, 1992.

3.1.4. The Salient features of the Share Purchase Agreement (‘SPA’) are as under:

1) Payment Consideration:

- The Acquirer will acquire the entire equity shares i.e. 10,70,600 Equity Shares from the Sellers at ₹4 per Equity Share amounting to ₹42,82,400.
- The Acquirers will pay an Earnest Money Deposit of ₹15,26,400 to the Sellers at the time of signing of Share Purchase Agreement.
- The Acquirers will pay an amount of ₹15,26,400 to the Sellers towards purchase consideration at any time before the completion of the Open Offer formalities but after RBI approval.
- The balance payment of ₹12,29,600 after adjusting the above mentioned clauses shall be paid to Sellers after the completion of Open Offer formalities.

However, as on date the entire purchase consideration has been paid to the Promoters/Sellers and the Equity Shares have been transferred to the demat account of respective Acquirers.

2) Conditions Precedent:

2.1. Conditions Precedent to the Closing Date:

The payment of the Purchase Price by the Acquirers on the Closing Date is conditional upon the satisfaction of the following conditions precedent (“the Conditions Precedent to Closing”) or the express waiver in writing by the party not responsible for satisfaction of the relevant condition precedent:

- The Sellers have agreed not to take any major corporate actions or decisions including mergers, demergers, spin-offs, amalgamations, consolidations, divestment or sale of the assets (including but not limited to a lease or exchange), capital expenditures or acquisition of Assets or businesses, creation of joint ventures / partnerships, or any investments exceeding 10% (ten) percent of the consolidated net worth of the Target Company on a cumulative basis in a Financial Year;
- The Sellers shall to the best of their knowledge confirmed that the representations and warranties of the Sellers set forth in the Second Schedule hereunder shall be true and correct in all respects and

- those not so qualified shall be true and correct in all material respects, in each case (i) as of the date of this Agreement; and (iii) as of the Closing Date, as though made on and as of each such date;
- (iii) To the best of the knowledge of the sellers, no judicial Order shall be in effect, and no Law shall have been enacted, promulgated or issued or deemed applicable to the transactions contemplated by or performance of this Agreement which would restrain, enjoin, make illegal or otherwise prohibit the consummation of the transactions contemplated hereby or thereby or the performance thereof would in any manner increase the cost of acquisition in the hands of the Acquirers;
 - (iv) Completion of legal, financial and tax due diligence to the satisfaction of the Acquirers; and
 - (v) The Sellers shall provide a certificate to all the Acquirers stating that, in the opinion of the Sellers, there has been no Material Adverse Effect.
 - (vi) The Sellers shall have delivered a certificate to the Acquirers confirming that there is no amount due and payable by the Company to any of the Sellers or by any of the Sellers to the Company.

2.2. Responsibility for Satisfaction:

The Sellers shall use its best endeavors to ensure that each of the aforementioned Conditions Precedent is fulfilled as soon as reasonably practicable and in any event within 60 (sixty) days from the date of execution of this Agreement or such extended date as may be mutually agreed upon between Sellers and Acquirers. If the conditions mentioned above are not fulfilled on or before 120 days, then the Acquirers shall have the right to terminate this Agreement and no party shall have any obligations or rights hereunder, other than with respect to any prior breach hereof.

On satisfaction of all the Conditions Precedent mentioned in above, the Sellers shall provide a written confirmation of the same separately to each of the Acquirers ("CP Confirmation Notice"). The CP Confirmation Notice shall be accompanied with duly authenticated or certified copies of all the necessary documents evidencing fulfillment of the Conditions Precedent mentioned in Clause 3.1 above. On receipt of the CP Confirmation Notice, the Acquirers will, if it is satisfied that the Conditions Precedent have been fulfilled to its satisfaction in accordance with this Agreement or waived by it, jointly issue a written notice to the Company confirming the same ("CP Satisfaction Notice").

3.1.5. The change in control of the Target Company is not through any Scheme of Arrangement.

3.1.6. The Acquirers reserves the right to nominate someone representing them to be a Director on the Board of the Target Company during the Offer Period in accordance with the Regulations by depositing 100% of the Maximum Consideration payable under the Offer in the Cash Escrow Account as required under Regulation 24(1) of the SEBI (SAST) Regulations. Accordingly, new directors including Acquirers were appointed w.e.f. January 31, 2020 as mentioned in point no. 5.10 below were appointed on the Board of the Target Company and the erstwhile directors namely Mr. Umed Kumar Nahata, Mrs. Dimple Gupta & Independent Directors namely Mr. Lakhi Prasad Saraogi, Mr. Deepak Banthia resigned w.e.f. the same date.

3.1.7. As per Regulation 26(6) of the SEBI (SAST) Regulations, the Board of Directors are required to constitute a committee of Independent Directors to provide reasoned recommendation on this Offer to the Eligible Shareholders. Such recommendation shall be published at least two (2) working days before the commencement of the Tendering Period in the same newspapers where the DPS was published in compliance with Regulation 26(7) of the SEBI (SAST) Regulations.

3.1.8. No other persons/individuals/entities are acting in concert with the Acquirers for the purpose of this Offer in terms of Regulation 2 (1) (q) of the SEBI (SAST) Regulations.

3.2. DETAILS OF THE PROPOSED OFFER

3.2.1. The PA announcing the Open Offer, under Regulation 3(1) and 4 read with Regulation 13, 14 and 15 of the Regulations was made on September 06, 2019 (Friday) and was submitted to Metropolitan Stock Exchange Limited, Mumbai ('MSEI'), Calcutta Stock Exchange Limited, Kolkata ('CSE') and to the Target Company on the same date and was filed with SEBI, Mumbai on September 09, 2019 (Monday).

3.2.2. In accordance with Regulations 13(4) and 14(3) of the SEBI (SAST) Regulations, the DPS was published on September 16, 2019 (Monday) in the following newspapers:

3.2.3. Simultaneously with the publication of DPS in the newspapers, a copy of the DPS was filed through the Manager to the Offer with SEBI, MSEI, CSE and the Target Company at its Registered Office.

3.2.4. This Offer is made by the Acquirers to all Eligible Shareholders, to acquire up to 10,50,000 Equity Shares representing 35% of the Equity Share Capital, at a price of ₹7.50 (Rupees Seven and Paise Fifty only) per Equity Share, to be paid in cash, in accordance with Regulation 9(1)(a) of the Regulations and subject to the terms and conditions set out in the PA, the DPS and LoF.

3.2.5. There is no differential pricing for the Offer.

3.2.6. This is not a Competing Offer in terms of Regulation 20 of the SEBI (SAST) Regulations. There has been no competing offer as of the date of this LoF.

3.2.7. The Offer is unconditional and not subject to any minimum level of acceptance from the shareholders. In terms of Regulation 19(1) of the Regulations, the Acquirers will accept those Equity Shares of the Target Company which are tendered in valid form in terms of this Offer upto a maximum of 10,50,000 Equity Shares representing 35% of the Equity Share Capital of the Target Company.

3.2.8. The Acquirers did not acquire any shares of the Target Company after the date of PA i.e. September 06, 2019 (Friday) up to the date of this LoF, except for acquisition of 10,70,600 Equity Shares pursuant to SPA.

3.2.9. In terms of Regulation 23 of the Regulations, the statutory approvals, if any, are refused, the Offer would stand withdrawn. In the event of withdrawal of this Offer, a Public Announcement will be made within two (2) working days of such withdrawal, in the same newspapers in which the DPS has been published and such Public Announcement will also be sent to SEBI, MSEI, CSE and the Target Company at its Registered Office.

3.2.10. As on date, the Manager to the Offer, Mark Corporate Advisors Private Limited does not hold any Equity Shares in the Target Company. The Manager to the Offer further declares and undertakes that they will not deal on their own account in the Equity Shares of the Target Company during the Offer Period as per Regulation 27(6) of the SEBI (SAST) Regulations.

3.2.11. The Equity Shares of the Target Company acquired by the Acquirers shall be free from all liens, charges and encumbrances together with all rights attached thereto, including the right to all dividends, bonus and rights offer declared hereafter.

3.2.12. As per Regulation 38 of SEBI (LODR) Regulations read with Rule 19A of the Securities Contract (Regulation) Rules, 1957, as amended ('SCRR'), the Target Company is required to maintain at least 25% Public Shareholding, on continuous basis for listing. Pursuant to completion of this Offer, assuming full acceptance, the Public Shareholding in the Target Company will not fall below the minimum public shareholding requirement as per SCRR as amended and the SEBI (LODR) Regulations, 2015.

3.3. OBJECT OF THE OFFER

3.3.1. This Offer is being made to the public shareholders of Target Company pursuant to and in compliance with regulation 3(1) and 4 of the Regulations.

3.3.2. The object of acquisition is to acquire substantial shares/voting rights accompanied by control over the Target Company. At present, the Acquirers does not have any plans to make major changes to the existing line of business of the Target Company except in the ordinary course of business. 4.2.4. He has not been prohibited by SEBI from dealing in securities, in terms of directions issued under section 11 B of the SEBI Act or any other regulations made under the SEBI Act.

4.2.5. 4.4. The Acquirers are Business Associates and came together to jointly control the Target Company.

4.5. The Acquirers will be the Promoter of the Target Company, after completing all the Open Offer formalities pursuant to the Regulations.

4.6. The Acquirers did not acquire any Equity Share of the Target Company either in the current financial year or in the period of eight financial years preceding the current financial year. However, the Acquirers have

entered into a Share Purchase Agreement on September 06, 2019 (Friday) for acquisition of 10,70,600 Equity Shares at a price of ₹4 per Equity Share and the said Equity Shares have been transferred to the Demat Account of the respective Acquirers during the month of February 2020.

- 4.7. Neither the Acquirers nor any of the entities with whom they are associated, are in Securities related business and registered with SEBI as a Market Intermediary.
- 4.8. Based on the information available, none of the Acquirers are in the list of 'wilful defaulters' issued by any bank, financial institution, or consortium thereof in accordance with guidelines on wilful defaulters issued by RBI and as per Regulation 2(1) (ze) of Regulations.
- 4.9. Based on the information available, none of the Acquirers have been declared as a fugitive economic offender under Section 12 of Fugitive Economic Offenders Act, 2018 (17 of 2018) as per Regulations 2(1) (ja) of Regulations.
- 4.10. The entities promoted or controlled by the Acquirers as mentioned in point no. 4.1.6, 4.2.6 and 4.3.6 above are neither holding any Equity Share nor participating or acting in Concert in the Open Offer.
- 4.11. As on date, the Acquirers have acquired Equity Shares pursuant to SPA and took over the control of the management of the Target Company after depositing an amount equivalent to 100% of the Offer size. Further, new directors including Acquirers as mentioned in point no. 5.10 below were appointed on the Board of the Target Company w.e.f. January 31, 2020.

5. BACKGROUND OF THE TARGET COMPANY-ORCHID SECURITIES LIMITED

- 5.1. The Target Company, bearing CIN L18209WB1994PLC062173 was incorporated on March 09, 1994 in the name of 'Orchid Securities Limited' in the State of West Bengal pursuant to the provisions of the Companies Act, 1956. There has been no change in the name of the Company during the last three years.
- 5.2. The current Registered Office is situated at 36A, Bentick Street, Kolkata-700 069, West Bengal. The Corporate Office is situated at C-222, GIDC, Makarpura Industrial Estate Vadodara-390 010 w.e.f. January 31, 2020
- 5.3. The Target Company is registered as Non-Banking Finance Company ("NBFC") with Reserve Bank of India ("RBI") bearing Registration Number as 05.00111 (without accepting public deposits) and its main business inter-alia includes investments/trading in shares and securities and providing loans and advances.
- 5.4. The Authorized Share Capital of the Target Company is ₹3,25,00,000 comprising of 32,50,000 Equity Shares of ₹10 each. The Paid-Up Equity Share Capital of the Target Company is ₹3,00,01,000 comprising of 30,00,100 Equity Shares of ₹10 each fully paid up.
- 5.5. The Equity Shares of the Target Company are listed on Metropolitan Stock Exchange of India Limited, ("MSEI") having a scrip symbol as 'Orchid' and Calcutta Stock Exchange Limited, Kolkata ("CSE") with scrip code as '025148'. The Equity Shares of the Target Company are infrequently traded within the meaning of explanation provided in Regulation 2(j) of the Regulations. The ISIN of the Target Company is INE077D01014.
- 5.6. As on date, the Target Company is fully compliant with the listing requirements and there has not been any non-listing of Equity Shares on any of the Stock Exchanges. However, The Target Company was suspended on the Calcutta Stock Exchange Limited w.e.f. March 21, 2014 due to some non-compliances of Listing Agreement. The trading in the Shares of the Target Company was revoked by the Calcutta Stock Exchange Limited w.e.f. April 01, 2016, after the necessary compliances were completed. Further, Metropolitan Stock Exchange of India Limited ("MSEI") vide its letter dated March 27, 2019 levied a penalty of ₹1,08,560 for non-compliance under Regulations 6(1) of SEBI (LODR) Regulations, 2015 pertaining to quarter ended December'2018 for which the payment was made on August 29, 2019. Further, MSEI vide its letter dated August 14, 2019 levied a penalty of ₹1,07,380 for non-compliance under Regulations 6(1) of SEBI (LODR) Regulations, 2015 pertaining to quarter ended June'2019 and the Target Company has taken up the matter with MSEI for its resolution.

In case of delay in receipt of any Statutory Approval(s), pursuant to Regulations 18(11) of the Regulations, SEBI may, if satisfied, that delay in receipt of requisite Statutory Approval(s) was not attributable to any wilful default, failure or neglect on the part of the Acquirer to diligently pursue such approvals, may grant an extension of time for the purpose of the completion of this Offer, subject to Acquirers agreeing to pay interest for the delayed period, provided where the Statutory Approval(s) extend to some but not all Equity Shareholders, the Acquirers has the option to make payment to such Shareholders in respect of whom no Statutory Approval(s) are required in order to complete this Open Offer. Further, in case the delay occurs on account of wilful default by the Acquirers in obtaining any Statutory Approval(s) in time, the amount lying in the Escrow Account will be liable to be forfeited and dealt with pursuant to Regulation 17(10)(e) of the Regulations.
