Re: Request for Informal Guidance by way of Interpretative letter -- Notification No. SEBI/LAD/NRO/GN/2018/10 dated 9th May 2018.

- There are 12 directors on our Board (as per List A enclosed) of which 6 are Independent
 Directors. Of the six independent Directors, one Independent Director (Ms Shobhana
 Ramachandhran) is a non-independent Director on another listed Company (India Motor
 Parts & Accessories Limited List of their Directors annexed vide List B) on whose board
 there is an Independent Director (Mr S Ravindran) who is a non-independent Director on our
 Board.
- 2. The above position is covered under Reg.16(1)(b)(viii) introduced with effect from 1st October 2018. Our understanding of this amendment <u>is that it does not apply to the existing independent Directors</u>, who have been appointed by the Shareholders under S. 149 of the Companies Act, 2013, and whose term will expire as per the term approved by the shareholders.
- Our understanding is strengthened by the wording of the new Regulation 17(1A) and the wording in the Regulation 25(1) both of which use the word 'continue' (which is absent in Reg. 16(1)(b)(viii).
- 4. For your ready reference we enclose the extracts of Regulations 16 (1)(b), 17(1A) and 25(1) with essential words highlighted, vide annexure C.
- 5. We request you to kindly confirm whether our interpretation is correct and that we need to apply Regulation 16(1)(b)(viii) only for new appointments / reappointments of Directors
- 6. We enclose Demand Draft No.518945 dated 27th August 2018 for ₹25000/- drawn on ICICi Bank in favour of 'Securities and Exchange Board of India' payable at Mumbai, towards fee for your Interpretative letter.
