

Detailed Public Statement (DPS) for the Shareholders of Yamini Investments Company Limited

in terms of Regulation 15(2) of SEBI (Substantial Acquisition of Shares and Takeovers) Regulations, 2011
(hereinafter referred to as "SEBI (SAST) Regulations"/"Regulations")

Open Offer for acquisition up to 62,400 (Sixty Two Thousand and Four Hundred Only) Equity Shares at a price of ₹15.00/- per fully paid up equity share from the Shareholders of Yamini Investments Company Limited (hereinafter referred to as "Target Company" or "YIL") by Mrs. Vandana Agarwal (hereinafter referred to as "Acquirer") pursuant to and in accordance with Regulation 4 of the SEBI (SAST) Regulations and subsequent amendments thereof.

This detailed public statement ("DPS") is being issued by Intensive Fiscal Services Pvt. Ltd., the Manager to the Offer ("Manager") on behalf of Mrs. Vandana Agarwal in compliance with Regulation 13 (4) of the SEBI (SAST) Regulations and subsequent amendments thereto pursuant to the Public Announcement filed on October 05, 2012 with the Stock Exchange/ SEBI/ Target Company in terms of Regulation 4 of the SEBI (SAST) Regulations.

I. ACQUIRER, TARGET COMPANY AND OFFER

A. Details of the Acquirer:

- Mrs. Vandana Agarwal daughter of Ramesh Chand Mittal aged about 33 years residing at 26/94, Near Bus station, Khatri pura, Nagaur, Rajasthan 341001, Tel No: 09331294161 and Fax no: 015-82246072 is the only Acquirer in terms of Regulation 2(1)(a) of the SEBI (SAST) Regulations.
- Presently, Mrs. Vandana Agarwal is having experience of more than two years in the field of financial consultancy.
- C.A. Gopal Bansal (Membership No. 501503), partner of Bansal Mangal Singhal & Goyal, Chartered Accountants having its Office at 325, Vardhman Grand Plaza, Manglam Place, Sector-3, Rohini, Delhi-110085, Telefax: 011-47527593, Mob No. 09350655363, E-mail: gopalbansalca@yahoo.com has certified vide certificate dated July 31, 2012 that the Net worth of Mrs. Vandana Agarwal is ₹ 19,50,000/- (Rupees Nineteen Lakhs Fifty Thousand only) as on July 31st, 2012.
- The Acquirer proposes to acquire 7,000 fully paid up equity shares of the Target Company constituting 2.92% of the paid up/voting capital of the Target Company pursuant to Share Purchase Agreement (hereinafter referred to as "SPA") dated October 05, 2012.
- The provisions of Chapter V & Chapter II of Regulations and Securities & Exchange Board of India (Substantial Acquisition of Shares & Takeovers) Regulations, 1997 respectively are not applicable to the Acquirer as she does not hold any shares of the Target Company and has not acquired any shares of the Target Company in the past.
- The Acquirer is not forming part of the Promoter group of the Target Company. As on date of this DPS, there is/are no nominee(s) of the Acquirer on the Board of Directors of the Target Company.
- The Acquirer has not been prohibited by SEBI from dealing in securities, in terms of directions issued under Section 11B of the SEBI Act, 1992, as amended (the 'SEBI Act') or any other Regulations made under the SEBI Act.

B. Details of Seller:

- Mr. Narayan Jha (hereinafter referred to as "Seller") residing at 1626/33, Naiwala, Karol bagh, Delhi-110005, India proposes to sell 7,000 fully paid up equity shares constituting 2.92% of the total paid up/voting capital of the Target Company to the Acquirer pursuant to SPA dated October 05, 2012 at a price of ₹ 10.00/- (Rupees Ten only) per equity share.
- As on date of this DPS, the Seller is the only Promoter of the Target Company.
- Before the aforementioned transaction, the Seller was holding 7,000 fully paid up equity shares, representing 2.92% of the voting capital of the Target Company.
- The Seller has not been prohibited by SEBI from dealing in securities, in terms of directions issued under Section 11B of the SEBI Act, 1992, as amended (the 'SEBI Act') or any other Regulations made under the SEBI Act.
- Target Company (Yamini Investments Company Limited):**
 - The Target Company was incorporated as "Yamini Investments Company Limited" on January 17, 1983 under the provisions of the Companies Act, 1956. The present registered office of the Target Company is 109, Trinity Bldg, Above AP Market, 261, S S Gaikwad Marg, Dhobitalao, Marine Lines, Mumbai, Maharashtra-400002, India, Tel No:- 022-22073080, Fax No:- 022-22073081, E-mail:- yamininvestments@gmail.com, Website:- www.yamininvestments.com.
 - As on the date of this DPS, the authorized share capital of the Target Company is ₹ 25,00,000/- (Rupees Twenty Five Lakhs only) divided into 2,50,000 equity shares of ₹10.00/- each. The issued, subscribed & paid up capital of the Company is ₹ 24,00,000/- (Rupees Twenty Four Lakhs only) comprises of 2,40,000 fully paid-up equity shares of ₹10.00/- each.
 - The trading in equity shares of the Target Company was suspended by Bombay Stock Exchange Limited (hereinafter referred to as "BSE") w.e.f. February 05, 2001 due to non compliance of listing agreement. Further, the Target Company received an In Principle approval from BSE for revocation of suspension in trading of equity shares of the Target Company vide its letter dated April 02, 2012. Thereafter the suspension in trading of equity shares was revoked by BSE w.e.f. May 29, 2012.
 - As on date of this DPS, there are no lock in shares, no partly paid up shares and no outstanding instruments in the nature of warrants / fully convertible debentures / partly convertible debentures etc. which are convertible into equity at any later date in the Target Company.
 - The Present Board of Directors of the Target Company are Narayan Jha, Mahesh Prasad Bansal, Kirti Agarwal and Meena Bansal.

D. Details of the Offer:

- The Acquirer hereby makes this Offer to the equity shareholders (other than parties to the SPA) of the Target Company to acquire up to 62,400 (Sixty Two Thousand and Four Hundred Only) fully paid up equity shares of ₹ 10.00/- each representing 26.00% of the voting capital of the Target Company in terms of the SEBI (SAST) Regulations at a price of ₹ 15.00/- (Rupees Fifteen only) per fully paid up equity share ("Offer Price") payable in cash.
- The offer is made to (i) all the equity shareholders (except parties to the SPA) whose names will be appeared on the register of members of the Target Company or beneficiaries on the beneficiary records of the Depository Participant as on the Identified Date, (ii) those persons who own the shares any time prior to the closure of the tendering period, but are not the registered shareholder(s).
- This Offer is subject to the receipt of the statutory and other approvals mentioned in paragraph VI of the DPS. In terms of Regulation 23 of the SEBI (SAST) Regulations, if the statutory approvals are refused, the Offer would stand withdrawn.
- This is not a conditional Offer and not subject to any minimum level of acceptance. The Acquirer will acquire all the equity shares of the Target Company that are validly tendered as per terms of the Offer subject to the terms and conditions mentioned in this DPS and in the Letter of Offer that will be sent to the Shareholders up to a maximum of 62,400 fully paid up equity shares.
- This is not a Competitive Bid in terms of regulation 20.
- The Acquirer has not acquired any shares of the Target Company during the 12 months period prior to the date of PA, save and except those that have been proposed to be acquired pursuant to the SPA dated October 05, 2012.
- The Manager to the Offer, Intensive Fiscal Services Private Limited does not hold any Equity Share in the Target Company as on date of this DPS. The Manager to the Offer further declares and undertakes that they will not deal in their own account in the Equity Shares of the Target Company during the Offer Period.
- The SPA is subject to compliance of provisions of SEBI (SAST) Regulations and in case of non compliance with the provisions of SEBI (SAST) Regulations; the SPA shall not be acted upon.
- As on the date of this DPS, the Acquirer does not have any intention to sell, dispose off or otherwise encumber any significant assets of YIL except in the ordinary course of business. The future policy for disposal of its assets, if any, will be decided by Target Company's Board of Directors, subject to the applicable provisions of the law and subject to the prior approval of the shareholders at a General Body Meeting of YIL in accordance with regulation 25(2) of Regulations. However, the Acquirer may give effect such alienation but subject to passing a special resolution by the shareholders of Target Company by way of a postal ballot and the notice for such postal ballot containing reasons as to why such alienation is necessary. The Acquirer intends to seek a reconstitution of the Board of Directors of the Target Company after successful completion of Offer.
- In terms of Clause 40A of the Listing Agreement with BSE read with Rule 19A(1) of the Securities Contracts (Regulations) Rules, 1957, the Target Company is required to maintain at least 25% public shareholding for listing on a continuous basis. The present Offer will not result in the public shareholding of the Target Company falling below the minimum level required as per the Listing Agreement.

II. BACKGROUND TO THE OFFER

- The Acquirer proposes to acquire 7,000 fully paid up equity shares pursuant to Share Purchase Agreement entered on October 05, 2012 at a price of ₹ 10.00/- (Rupees Ten only) per fully paid up equity share aggregating to ₹ 70,000/- (Rupees Seventy Thousand only) (hereinafter referred to as the "Paid Shares"), details of which are as follows:

- The Acquirer intends to take control over the Target Company & make changes in the Board of Directors of the Target Company subsequent to the completion of this Open Offer in accordance hereof.

- Thus Open Offer is being made by the Acquirer in compliance with Regulation 4 read with other applicable provisions of the SEBI (SAST) Regulations.
- The Acquirer is hereby making a mandatory Open Offer in terms of SEBI (SAST) Regulations to the equity shareholders (except parties to the SPA) of the Target Company to acquire 62,400 fully paid up equity shares ("Offer Size") bearing a face value of ₹ 10.00/- each representing 26.00% of the total issued, subscribed, paid up and voting capital of the Target Company at a price of ₹ 15.00/- (Rupees Fifteen Only) per fully paid up equity share, payable in cash, aggregating to ₹ 9,36,000/- (Rupees Nine Lakhs and Thirty Six thousand only) subject to the terms and conditions mentioned in this DPS and in the Letter of Offer that will be circulated to the shareholders in accordance with the regulations, ("Letter of Offer"/"Offer Document") whose names appear on the register of members of the Target Company or beneficiaries on the beneficiary records of the Depository Participant as on the Identified date i.e. November 19, 2012.

OBJECT & PURPOSE OF ACQUISITION & FUTURE PLANS:

- The prime object of the Offer is to acquire substantial stake & change the control and management of the Target Company. Mrs. Vandana Agarwal is the only Acquirer for the proposed Open Offer. The Acquirer is yet to finalize on how she would implement the future plans. She also aims to expand the business horizon under corporate status for diversifying into different activities subject to approval of the shareholders. The Acquirer reserves the right to modify the present structure of the business in a manner which is useful to the larger interest of the shareholders. Any change in the structure that may be affected will be in accordance with the laws applicable.

- In view of the above parameters considered and in the opinion of the Acquirer and Manager to the Offer, the Offer Price of ₹ 15.00/- per fully paid up equity share is justified in terms of regulation 8 (2) of the SEBI (SAST) Regulations.
- No adjustment has been carried out in the offer price as there were no corporate actions were announced before or as on the date of this DPS.
- Irrespective of whether a competing offer has been made or not, the Acquirer may make upward revision(s) to the offer price or offer size subject to the other provisions of these regulations, at any time prior to the commencement of the last three working days before the commencement of the tendering period i.e. up to November 28, 2012.
- Where the Acquirer has acquired or agreed to acquire any share or voting right in the Target Company during the offer period, whether by subscription or purchase, at a price higher than the offer price, the offer price shall stand revised to the highest price paid or payable for any such acquisition. Provided that no such acquisition shall be made after the third working day prior to the commencement of the tendering period and until the expiry of the tendering period. In case of revision in the Offer price, shareholders would be notified.
- Where the Acquirer acquires shares of the Target Company during the period of twenty-six weeks after the tendering period at a price higher than the offer price under these regulations, the Acquirer shall pay the difference between the highest acquisition price and the offer price, to all the shareholders whose shares were accepted in the open offer, within sixty days from the date of such acquisition. However no such difference shall be paid in the event that such acquisition is made under an Open Offer under the SEBI (SAST) Regulations or pursuant to SEBI (Delisting of Equity shares) Regulations, 2009 or open market purchases made in the ordinary course on the Stock Exchange, not being negotiated acquisition of Equity shares whether by way of bulk deals, block deals or in any other form.

V. FINANCIAL ARRANGEMENTS

- The total fund requirement or the maximum consideration for the Open Offer assuming full acceptance of the Offer would be ₹ 9,36,000/- (Rupees Nine Lakhs Thirty Six Thousand only) i.e. consideration payable for acquisition of 62,400 fully paid equity shares of the Target Company at an Offer Price of ₹ 15.00/- (Rupees Fifteen only) per equity share.
- In accordance with Regulation 17 of the Regulations, the Acquirer has opened an Escrow Account under the name and title of "YAMINI INVESTMENTS LIMITED ESCROW ACCOUNT - 0018-Q29197-050" with IndusInd Bank Limited - Mumbai ("Escrow Bank") and made a deposit of ₹ 2,50,000/- (Rupees Two Lakhs Fifty Thousand only) being more than 25% of the total consideration payable in accordance with the SEBI (SAST) Regulations. In term of an agreement dated October 05, 2012 amongst the Acquirer, Manager to the Offer and the Escrow Bank ("Escrow Agreement"), Manager to the Offer have been solely authorized to operate and to realize the value lying in the Escrow Account in terms of the SEBI (SAST) Regulations.

- The Acquirer has adequate resources to meet the financial requirement under the Open Offer as certified by C.A. Gopal Bansal (Membership No. 501503), partner of Bansal Mangal Singhal & Goyal, Chartered Accountants dated October 05, 2012.
- No borrowing from any Bank/ Financial Institution is being specifically made for this purpose.
- Based on the above and in light of the escrow arrangements set out above, the Manager to the Offer is satisfied with the ability of the Acquirer to implement the Offer in accordance with the Regulations as firm financial arrangements are in place to fulfill the obligations under the Regulations.
- In case of revision in the Offer Price or Offer Size, the Acquirer will further make Deposit with the escrow bank of difference amount between previous Offer fund requirements and revised Offer fund requirements to ensure compliance with Regulation 18(5) (a) of the SEBI (SAST) Regulations.

VI. STATUTORY AND OTHER APPROVALS

- As on date of this DPS, there are no statutory approvals required for the acquisition of equity shares that would be tendered pursuant to this Offer. If any statutory approvals are required or become applicable, the Offer would be subject to the receipt of such other statutory approvals. The Acquirer will not proceed with the Offer in the event that such statutory approvals which are required are refused in terms of Regulation 23 of the SEBI (SAST) Regulations.
- If the Acquirer is unable to make the payment to the shareholders who have accepted the open offer within such period as specified in below table titled as "TENTATIVE SCHEDULE OF ACTIVITY" owing to non-receipt of statutory approvals as required, the Board may, where it is satisfied that such non-receipt was not attributable to any willful default, failure or neglect on the part of the Acquirer to diligently pursue such approvals, grant extension of time in terms of Regulation 18(11) of the Regulations for making payments, subject to the Acquirer agreeing to pay interest to the shareholders for the delay at such rate as may be specified.
- Where the statutory approval extends to some but not to all shareholders in respect of making payment, the Acquirer will have the option to make payment to such shareholders in respect of whom no statutory approvals are required in order to complete the open offer.
- No approvals are required from FIs/Banks for the Offer.
- The Offer would be subject to all other statutory approvals that may become applicable at a later date before the completion of the Offer.
