During such period, there may be fluctuations in the market price of the equity shares of the Target Company. Accordingly, the Acquirer makes no assurance with respect to the market price of the shares both during the tendering period and upon the completion of the Offer, and disclaims any responsibility with respect to any decision by any shareholder of the Target Company on whether to participate or not to participate in the Offer.
- c. Equity Shares, once tendered through the Form of Acceptance-cum-Acknowledgement in the Offer, cannot be withdrawn by the Equity Shareholders during the Tendering Period.
- d. The Acquirer and the Manager to the Offer do not accept any responsibility for statements made otherwise than in the Letter of Offer or the Public Announcement or the DPS and anyone placing reliance on any other source of information (not released by the Acquirer or the Manager to the Offer) would be doing so at his/her/their own risk.

THE DRAFT LETTER OF OFFER HAS BEEN SUBMITTED TO SEBI FOR A LIMITED PURPOSE OF OVERSEEING WHETHER THE DISCLOSURES CONTAINED THEREIN ARE GENERALLY ADEQUATE AND ARE IN CONFORMITY WITH THE REGULATIONS. THIS REQUIREMENT IS TO FACILITATE EQUITY SHAREHOLDERS OF ZENITH CAPITALS LIMITED TO TAKE AN INFORMED DECISION WITH REGARD TO THE OFFER. 3 DETAILS OF THE OFFER

3.1 Background of the Offer

- 3.1.1 This Open Offer (the “Offer”) is being made by the Acquirer to the shareholders of the Target Company in compliance with regulations 3(1) and 4 of the SAST Regulations triggered pursuant to acquisition of substantial shares and voting rights and control of the Target Company in terms of the Share Purchase Agreement (“SPA”) dated February 25, 2013.
- 3.1.2 The Acquirer has entered into a Share Purchase Agreement (‘SPA’) on February 25, 2013 with the Sellers for acquisition of 14,32,450 equity shares of ₹ 10/- each, constituting 74.61% of the issued equity share capital of the Target Company at a price of ₹ 54 (Rupee Fifty Four only) per equity share (“Negotiated Price”) for a total consideration of ₹ 7,73,52,300/- (Rupees Seven Crores Seventy Three Lacs Fifty Two Thousand Three Hundred only) (“Purchase Consideration”). As per the stock exchange filings by the Target Company, the Sellers belong to the Promoter Group of the Target Company. Full details of the Sellers are given below:

3.1.3 After the completion of this Open Offer and pursuant to the transfer of the shares so acquired, the Acquirer shall hold the majority of the Equity Shares by virtue of which they will be in a position to exercise effective management and control over the Target Company.

3.1.4 The salient features of the SPA are as follows:

- a) The Acquirer shall purchase from the Sellers and the Sellers shall sell to the Acquirer, as legal and beneficial owners, the Sale Shares free from all encumbrances and together with all rights, title, interest and benefits appertaining thereto, for the Purchase Consideration to the Sellers by the Acquirer.
- b) The Target Company and the Sellers shall ensure that from the date of execution of the SPA till the completion of Open Offer, the Sellers & Target Company shall carry on the business of the Target Company in the ordinary course of business.
- c) The Acquirer shall comply with the provisions of SEBI Takeover Regulations and shall not conceal any facts so as to ensure smooth completion of the transaction.
- d) The purchase and sale of shares under this SPA shall be completed within twenty-six weeks from the date of expiry of offer period in terms of the SEBI SAST Regulations.

3.1.5 There is no Person Acting in Concert with the Acquirer.

3.1.6 There is no separate arrangement for the proposed change in control of the Target Company except for the terms as mentioned in SPA.

3.1.7 The Acquirer has not been prohibited by SEBI from dealing in securities, in terms of direction issued under Section 11B of the SEBI Act or under any of the Regulations made under the SEBI Act, 1992.

3.1.8 The recommendation of the committee of Independent Directors as constituted by the Board of Directors of the Target Company on the Offer will be published at least two working days before the commencement of the tendering period, in the same newspapers where the DPS was published and a copy whereof shall be sent to SEBI, BSE and Manager to the Offer and in case of a competing offer/s to the manager/s to the open offer for every competing offer.

3.2 Details of the Proposed Offer

3.2.1 In accordance with regulation 13(4) of the SEBI SAST Regulations, the Acquirer has made a Detailed Public Statement within 5 (five) working days from the date of Public Announcement. In accordance with regulation 14(3) of the SEBI SAST Regulations, the Detailed Public Statement has been published in the following newspapers:

3.2.2 A copy of the Detailed Public Statement for the Open Offer is also available on the SEBI website (www.sebi.gov.in)

3.2.3 The Acquirer is making an offer to acquire 4,87,550 Equity Shares of the face value of ₹ 10 each ("Offer Share"), representing in aggregate 25.39% of the equity share capital of the Target Company at a price of ₹ 54 (Rupee Fifty Four only) per equity share of ₹ 10 each payable in cash.

3.2.4 This is not a competing offer and there have been no competing offers as on the date of this letter of offer.

3.2.5 This Offer is neither conditional nor subject to any minimum level of acceptance.

3.2.6 The Acquirer will acquire 4,87,550 equity shares that are validly tendered in accordance with the terms of the Offer at the offer price.

- 3.2.7 The equity shares of the Target Company will be acquired by the Acquirer free from all liens, charges and encumbrances together with all rights attached thereto, including the right to all dividends, bonus and rights offer declared hereafter.
- 3.2.8 There are no Persons acting in Concert in relation to this Offer and the equity shares tendered and accepted pursuant to the Offer will be acquired by the Acquirer only.
- 3.2.9 The Acquirer has not acquired any shares of the Target Company from the date of the PA up to the date of this letter of Offer.
- 3.2.10 The Manager to the Offer, Microsec Capital Limited does not hold any Equity Shares in the Target Company as at the date of PA. The Manager to the Offer further declares and undertakes that they will not deal on their own account in the Equity Shares of the Target Company during the Offer Period.
- 3.2.11 Pursuant to this Offer, the public shareholding in the Target Company may reduce to less than the minimum public shareholding required as per the Securities Contracts (Regulation) Rules, 1957 as amended and the Listing Agreement. The Acquirer undertakes that if the public shareholding is reduced to below such minimum level they will take necessary steps to facilitate compliances of the Target Company with the relevant provisions of the Listing Agreement and other provisions of applicable laws, within the time period mentioned therein. Further, the Acquirer shall not be eligible to make a voluntary Delisting Offer under the SEBI (Delisting of Equity Shares) Regulations, 2009, unless a period of twelve months has elapsed from the date of completion of the Offer Period as per regulation 7(5) of the SEBI (SAST) Regulations.

3.3 Object of the Acquisition

- 3.3.1 After the completion of this Open Offer and pursuant to the transfer of the shares so acquired, the Acquirer shall hold the majority of the Equity Shares by virtue of which they will be in a position to exercise effective management and control over the Target Company.
- 3.3.2 The Acquirer may continue the existing business of the Target Company or may diversify its business activities in future with prior approval of Shareholders. The main purpose of takeover is to expand the Company's business activities through exercising effective management and control over the Target Company. However, no firm decision in this regard has been taken or proposed so far.
- 3.3.3 The Acquirer has no plans to alienate any significant assets of the Target Company for a period of two years except in the ordinary course of business of the Target Company. The Target Company's future policy for disposal of its assets, if any, for two years from the completion of Offer will be decided by its Board of Directors, subject to the applicable provisions of the law and subject to the approval of the shareholders through Special Resolution passed by way of postal ballot in terms of regulation 25(2) of SEBI (SAST) Regulations.

4 BACKGROUND OF THE ACQUIRER

- 4.1 Mansa Developers Private Limited ("MDPL") is a private limited company incorporated under the Companies Act, 1956 on October 20, 2011 having Corporate Identity Number of U70109WB2011PTC168740. The registered office is at 7A, Bentick Street, Kolkata – 700 001. There has been no change in the name of the Acquirer since its incorporation.
- 4.2 The main objects of the Acquirer as per its Memorandum of Association is to construct, build, take on lease, purchase or acquire in any manner whatsoever any apartment, house, flats, shops, offices, clubs, townships, markets or other buildings and for these purposes to purchase, take on lease or in exchange, hire or otherwise acquire and hold any land and prepare layout etc.
- 4.3 The shares of the Acquirer are not listed or traded on any Stock Exchange.
- 4.4 The promoters of the Acquirer are Mr. Shekhar Madhukar Kulkarni and Mr. Yatin Krishnakumar Potdar. The Acquirer does not belong to any group.
- 4.5 The Acquirer has never acquired any shares of the Target Company. Hence the provisions of the chapter V of the SEBI SAST Regulations 2011 or chapter II of the SEBI SAST Regulations 1997 are not applicable to the Acquirer.
